



OHIO EDCHOICE SCHOLARSHIP EXPANSION PROGRAM – GRADES K-12

Requirements for Enrollment at Legacy Christian Academy

Tuition and Fees

The parents of EdChoice Expansion Scholarship recipients are responsible for the following fees:

TUITION

EdChoice allows \$5,500.00 for students in grades K-8 and \$7,500.00 for students in grades 9-12 who have been approved for the EdChoice Expansion Program. This program requires that the applicant's family must have income at or below 250% of the Federal Poverty Guidelines to be eligible to apply.

1. As you continue in the program by re-enrolling your child each year, the following income requirements will be in place in order for you to be eligible for the scholarship:
 - 0 – 200% - Full scholarship (Low Income Status) - parent does not pay remaining tuition
 - 201%-250% - Full scholarship - parent pays remaining tuition
 - 251% - 300% - Scholarship reduction of 25% - parent pays remaining tuition
 - 301% - 400% - Scholarship reduction of 50% - parent pays remaining tuition
 - Over 400% - Cannot renew scholarship
2. If the family's income changes for the next school year and does not meet the low income status requirements, the family will be responsible for the full tuition difference between the scholarship amount and full LCA tuition.
 - EdChoice families can apply for LCA Financial Aid (based on need) for up to 50% of the remaining tuition.

Please note: The Ohio Department of Education issues checks for your child's tuition monthly during the school year. The checks are mailed to the school and issued in the name of the parent and the school. It is your responsibility to come to the school to endorse the check when you are notified that it has been received. There is a limited Power of Attorney (POA) form available for you to sign if you would like the school to sign the EdChoice checks on your behalf. We have a notary available on site.

PSA

Per Student Assessment covers a variety of academic materials, facility costs, and student life events. This charge is not covered by the scholarship.

6th-12th GRADE ATHLETIC/DRAMA PARTICIPATION FEES

The 6th-12th grade athletic participation fee is \$175 per student per sport. The 7th-12th grade drama participation fee is \$175 per student per production. There is a family cap of \$700 for athletic participation fees. The participation fees will automatically be added to your tuition account if not paid by cash/check to the Business Office before the notification deadline. SCHOOL SUPPLIES

A supply list will be posted on our website (www.legacyknights.org). These items should be sent with your child to Meet-the-Teacher night or on the first day of school.

UNIFORMS (GRADES K-12)

Uniforms (LCA logo required for 7-12) must be purchased from an LCA approved vendor (Lands' End or Educational Apparel) and be in compliance with the school's dress code policy (see Parent/Student Handbook).

Provision of Special Services

- LCA participates in the National School Lunch Program. Students who qualify may receive lunch at no cost or at a reduced rate.
- We do not provide Before and After School Care. Students can arrive no earlier than 7:15 a.m. or be on campus no later than 3:30 p.m. unless participating in school-sponsored extracurricular activities.
- Intervention services are provided at an additional cost.

Transportation

- Please contact your local school district to inquire about available busing options. If transportation cannot be provided by your school district, parents may be eligible to receive a financial stipend from their respective school district.
- Because there is no guarantee that bus transportation will be provided and because this information will not be made available until shortly before school begins, it is the family’s responsibility to have a secondary plan that provides transportation to and from school each day.

Attendance

- The Ohio Department of Education will not renew EdChoice scholarships if a student has more than 20 unexcused absences during the school year.
- Student absences must be reported to the Main Office no later than 8:30 a.m.
- An absence will be considered excused if it meets the criteria established by the Ohio Department of Education for the EdChoice Program and if a parental note or email explaining the absence is sent to the Main Office.
- Absences for an illness that exceeds 3 consecutive days must be documented by a physician’s excuse.

The following documentation is required for submitting an EdChoice Scholarship Application:

- Proof of address (copy of recent utility bill in the parent’s name, monthly mortgage statement, or rental lease agreement). If the parent(s) and child live with another individual, additional documentation will be required.
- Copy of the child’s birth certificate
- Custody documentation (if applicable)
- EdChoice Scholarship Program Request Form
- Income Verification Form submitted online (if applicable – all families applying for Ed Choice Expansion and those applying for Traditional Ed Choice who are at or below the 250% Federal poverty level).
- Attach and submit a signed copy of this form with your application to the LCA office.

The following documentation is required for submitting an EdChoice Scholarship Renewal Application:

- Proof of address (copy of recent utility bill in the parent’s name, monthly mortgage statement, or rental lease agreement). If the parent(s)and child(ren) live with another individual, additional documentation will be required.
- Income Verification Form submitted online (if applicable – all families applying for Ed Choice Expansion and those applying for Traditional Ed Choice who are at or below the 250% Federal poverty level).
- Attach and submit a signed copy of this form with your application to the LCA office.
