Gift card pick-up is Thursday, December 2<sup>nd</sup> at 7:45am-8:15am and 2:45-3:30pm inside the front door of Lincoln. For your protection, an ID will be required.

**Shop with Scrip all year.** Use Scrip gift cards to pay for everyday purchases and earn rebates all year round with ShopWithScrip's new RaiseRight app. You can purchase physical gift cards, ecards, or reloads and pay using your linked bank account. If you are interested in using the RaiseRight app, simply fill out the attached Scrip program agreement and return it to the school. A link will be sent to your email to set up an online Scrip account.

**Those rebates add up!** You can earn hundreds of dollars each year by using Scrip gift cards to pay for items like groceries, gas, household essentials, clothing, restaurants, airline tickets, hotels, and more!
